Management Discussion of Fund Performance

October 21, 2011

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments during the past six months that have affected the Fund's performance and outlook since March 31, 2011, the Fund's most recent fiscal year-end. For information on the Fund's longer-term performance, please refer to the *Past Performance* section of the report. This report should be read in conjunction with the Annual Management Report of Fund Performance for the year ended March 31, 2011. In this report, "Mackenzie" refers to Mackenzie Financial Corporation, the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

The Fund's NAV declined by 26.3% to \$675.7 million at September 30, 2011, from \$917.2 million at March 31, 2011. This change was composed primarily of \$137.4 million in net losses (after including dividend and interest income) from investment performance, after deducting fees and expenses, and \$101.2 million in net redemptions. The performance of the Fund's Series A securities is discussed below. The performance of all series is shown in the *Past Performance* section of the report. Where series returns differ, it is primarily because different levels of fees and expenses were charged to each series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series.

Investment Performance

During the six-month period, the Fund's Series A securities returned -16.4% (after deducting fees and expenses paid by the series). This compares with the S&P/TSX Composite Index return of -16.6% and a return of -12.8% for a new blended index composed of a 70% weight in the S&P/TSX Composite Dividend Index (returned -14.4%) and a 30% weight in the MSCI World Index (returned -9.2%). It also compares with a return of -13.6% for the previous blended index, which was composed of a 60% weight in the S&P/TSX Composite Index and a 40% weight in the MSCI World Index. The S&P/TSX Composite Dividend Index, which includes only the dividend-paying stocks within the S&P/TSX Composite Index, replaced the latter in the blended index in order to provide a more meaningful comparison to the mandate of the Fund. Also, the weighting of foreign equities within the blend was reduced to better reflect the portfolio managers' projected asset mix. All index and series returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in the index without incurring fees, expenses and commissions, which are not reflected in the index returns.

The Fund slightly outperformed the broad-based S&P/TSX Composite Index due to its allocation to foreign securities, as U.S. equities outperformed Canadian equities. Also, dividend-paying stocks fared better than non-dividend-paying stocks as the markets declined during the period.

The Fund underperformed the previous and new blended indices, which account for the Fund's foreign exposure, due to weak stock selection among its foreign holdings. The Fund's overweight exposure to the energy sector, specifically large-cap energy producers, detracted from performance because energy was a major detractor from index performance during the period. The Fund's lower exposure to real estate investment trusts and utilities also detracted from results, though the impact was tempered by being underweight the materials and overweight the telecommunication services sectors.

The Fund did not fully benefit from the 8.0% appreciation of the U.S. dollar relative to the Canadian dollar in the period because approximately half of its U.S. dollar exposure, as well as all its exposure to the euro and the British pound, was hedged. The Fund had less exposure to foreign equities than the blended index, ending the period with a 20.4% allocation.

Fees and Expenses

The annualized management expense ratio ("MER") for Series A of 2.47% during the six-month period ended September 30, 2011, was slightly higher than the MER of 2.46% for the year ended March 31, 2011. The MERs (before and after waivers or absorptions) for each series are presented in the *Financial Highlights* section of this report. The MER for Series O decreased during the period because effective November 3, 2010, the administration fee for Series O securities was payable directly to Mackenzie by Series O investors, not by the Fund. Prior to this date, the administration fee was paid by the Fund.

The Governments of Ontario and British Columbia harmonized their provincial sales taxes with the federal goods and services tax effective July 1, 2010. This increases the amount of taxes paid by the Fund on its expenses, including but not limited to management and administration fees during the period.

The MER for each series consists of the management fee, administration fee and other fund costs, as applicable to that series. Other fund costs include taxes (including but not limited to GST/HST and income tax), interest and borrowing costs, fees and expenses of the Mackenzie Funds' Independent Review Committee ("IRC"), any fees related to external services that were not commonly charged in the Canadian mutual fund industry as at June 15, 2007, and the costs of complying with any new regulatory requirements after June 15, 2007.

Large Investor Activity

The Fund's net redemptions during the six-month period ended September 30, 2011, included net redemptions of \$22.0 million by top funds managed by Mackenzie and net redemptions of \$24.1 million due to rebalancing activity within asset allocation programs managed by Mackenzie.

Recent Developments

The Fund adopted a more defensive posture during the summer months, highlighted by a significant reduction in its energy, industrials and information technology exposure, and a significant increase in its portfolio

yield. The portfolio managers find equity valuations attractive. However, cash reserves are likely to remain above normal at around 5% so that the Fund can take advantage of opportunities that arise from continuing market volatility.

Within Canada, the Fund's financial holdings favour banks over insurance companies. Holdings in the energy sector favour energy producers that can maintain their distributions despite lower oil and gas prices. Holdings in the materials sector favour fertilizers, mining and companies that benefit from low natural gas feedstock costs. The Fund retains a healthy exposure to gold producers because they are extremely profitable at current gold prices and could increase dividends substantially. Foreign holdings favour U.S. and European multinationals, which provide access to the growth of emerging economies at what the portfolio managers believe to be attractive valuations.

Future Accounting Standards

As previously confirmed by the Canadian Accounting Standards Board ("AcSB"), most Canadian publicly accountable entities adopted all International Financial Reporting Standards ("IFRS"), as published by the International Accounting Standards Board ("IASB"), on January 1, 2011. However, the AcSB has allowed most investment funds to defer adoption of IFRS until fiscal years beginning on or after January 1, 2013. Accordingly, the Fund will adopt IFRS for its fiscal period beginning April 1, 2013, and will issue its initial financial statements in accordance with IFRS, including comparative information, for the interim period ending September 30, 2013.

Mackenzie has identified the key differences between IFRS and Canadian generally accepted accounting principles ("GAAP") that are expected to affect the Fund, and has developed an IFRS changeover plan, including a formal project governance structure, that addresses key elements of the conversion to IFRS. Elements of the plan include evaluating the impacts of the changeover on all business activities, accounting policies, information technology and data systems, internal controls over financial reporting, and disclosure controls and procedures. As the Fund's changeover plans are implemented, requirements for financial reporting resources and training are being modified appropriately.

Based on Mackenzie's current evaluation of the differences between GAAP and IFRS, the adoption of IFRS is not expected to have a significant impact on the calculation of NAV per security. IFRS is expected to affect the overall presentation of financial statements and result in additional disclosure in the accompanying notes. Mackenzie continues to monitor changes to IFRS proposed by the IASB and relevant amendments by the AcSB, and the current assessment and IFRS changeover plans may change if new standards are issued or interpretations of existing standards are revised.

Related Party Transactions

The following arrangements result in fees paid by the Fund to Mackenzie or to companies affiliated with the Fund.

Management and Administration Services

For each applicable series, the Fund paid management fees and administration fees, including any implementation period adjustments, to Mackenzie at the annual rates specified under *Fund Formation and Series Information* in this report and as more fully described in the Prospectus. In return for the administration fees, Mackenzie pays all costs and expenses (other than certain specified fund costs) required to operate the Fund that are not otherwise included in management fees. 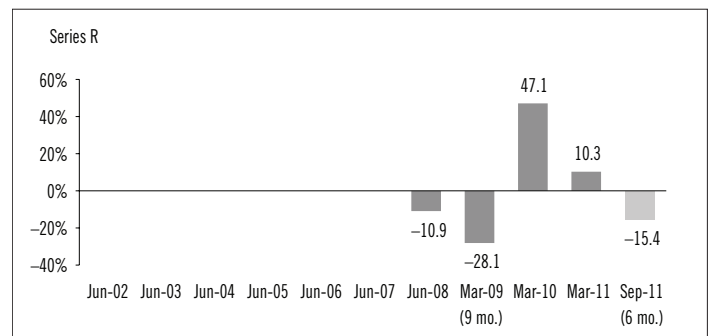
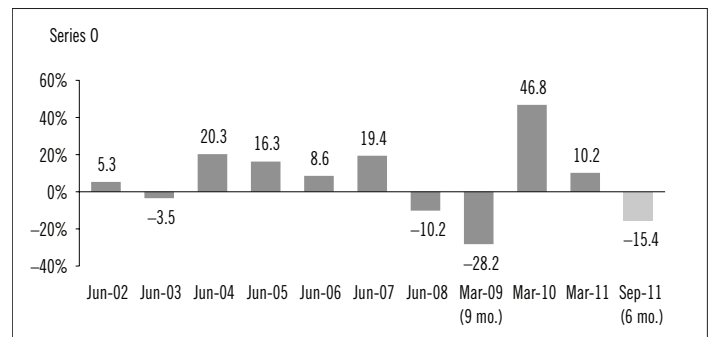
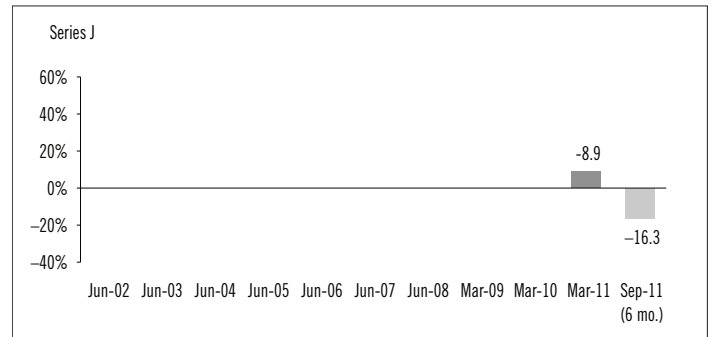
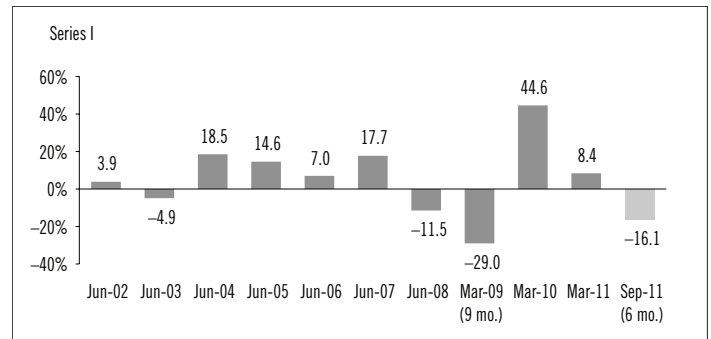
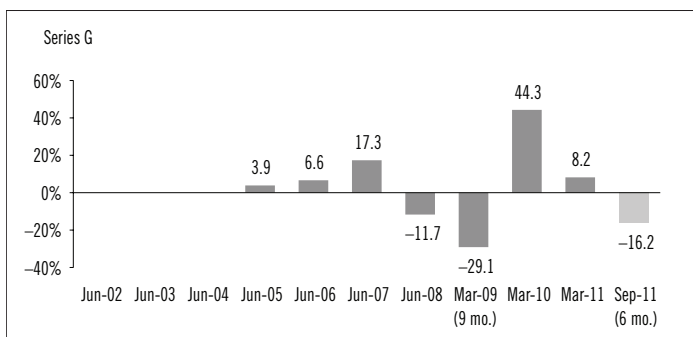
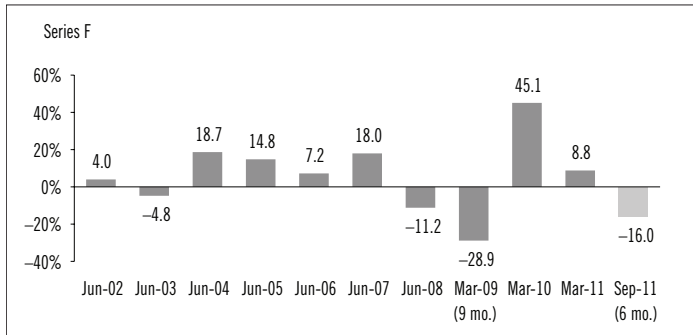
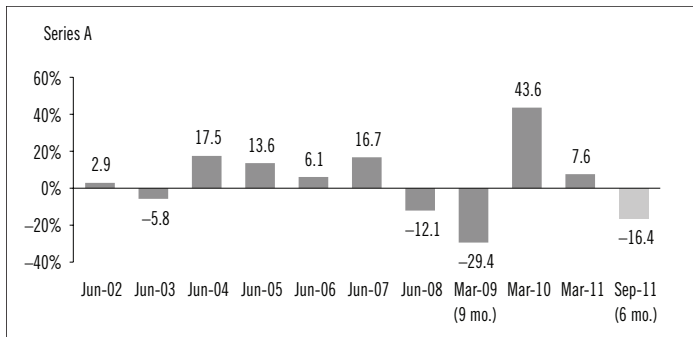
Mackenzie is wholly owned by IGM Financial Inc. ("IGM"). IGM is a subsidiary of Power Financial Corporation, which in turn is a subsidiary of Power Corporation of Canada. Power Financial Corporation also owns a majority of Great-West Lifeco Inc., which is therefore considered an affiliate of Mackenzie. At September 30, 2011, the Fund had \$26.4 million invested in securities issued by Power Corporation of Canada and \$4.4 million invested in securities issued by Great West Lifeco Inc. that represented 4.6% of the Fund's NAV. In making these investments, Mackenzie relied on the approval of the IRC. The IRC issued the approval on the basis that these investments would be made in compliance with Mackenzie's policies.

Investment funds managed by Mackenzie may invest in certain securities offered by the Fund on a prospectus-exempt basis in accordance with the investment objectives of those funds. All transactions are executed in accordance with standing instructions approved by the IRC and based on the NAV per security on each transaction day. At September 30, 2011, funds managed by Mackenzie owned 5.7% of the Fund's NAV.



Past Performance

The following bar charts present the performance of each series of the Fund for the six-month period ended September 30, 2011, for the years ended March 31, 2011 and 2010, for the nine-month period ended March 31, 2009, and for each of the previous years ended June 30. Management Fees

The management fee for each applicable series is calculated daily as a percentage of its NAV. The Fund's management fees were used by Mackenzie to pay for the costs of managing the investment portfolio, providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio, and providing other services. Mackenzie also used the management fees to fund sales commissions, trailing commissions and any other compensation (collectively "distribution-related payments") to registered dealers and brokers whose clients invest in the Fund.

The following dealers affiliated with Mackenzie may be entitled to distribution-related payments from Mackenzie on the same basis as unrelated registered brokers and dealers: IPC Securities Corporation, Investors Group Securities Inc., M.R.S. Securities Services Inc., IPC Investment Corporation, Investors Group Financial Services Inc., M.R.S. Inc., M.R.S. Correspondent Corporation and Partners in Planning Financial Services Ltd. On September 2, 2011, Mackenzie entered into a transaction which, subject to regulatory approvals, is expected to result in M.R.S. Inc., M.R.S. Securities Services Inc. and M.R.S. Correspondent Corporation no longer being subsidiaries of Mackenzie.

Mackenzie used approximately 40% of the total management fee revenues received from all Mackenzie funds during the period to fund distribution-related payments to registered dealers and brokers. In comparison, such distribution-related payments for the Fund represented on average 35% of the management fees paid by all applicable series of the Fund during the period. The actual percentage for each series may be higher or lower than the average depending on the level of trailing commissions and sales commissions paid for that series.

Fund Formation and Series Information

The Fund may have undergone a number of changes, such as a reorganization or a change in manager, mandate or name. A history of the major changes affecting the Fund in the last 10 years can be found in the Fund's Annual Information Form.

Date of Formation December 31, 1977

The Fund may issue an unlimited number of securities of each series. The number of issued and outstanding securities of each series is disclosed in *Financial Highlights*.

Series A securities are offered to retail investors investing a minimum of \$500.

Series E securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest a minimum of \$250,000.

Series F securities are offered to investors who are enrolled in a dealer-sponsored fee-for-service or wrap program, who are subject to an asset-based fee rather than commissions on each transaction and who invest at least \$500; they are also available to employees of Mackenzie and its subsidiaries, and directors of Mackenzie.

Series G securities are offered to retail investors investing a minimum of \$500 who are members of a group RRSP, DPSP, TFSA or pension plan.

Series I securities are offered to retail investors investing a minimum of \$500 in a qualified group plan with a minimum of \$20,000,000 in assets, or investors investing a minimum of \$500,000 who participate in the Portfolio Architecture Service or Open Architecture Service.

Series J securities are offered to investors investing a minimum of \$250,000.

Series O securities are offered to investors investing a minimum of \$500,000 who have entered into a Series O account agreement with Mackenzie, and also available to certain qualifying employees of Mackenzie and its subsidiaries.

Series R securities are offered only to other affiliated funds and certain institutional investors in connection with fund-of-fund arrangements.

An investor in the Fund may choose among different purchase options that are available under each series. These purchase options are a sales charge purchase option, a redemption charge purchase option and a low-load purchase option. The charges under the sales charge purchase option are negotiated by investors with their dealers. The charges under the redemption charge and low-load purchase options are paid to Mackenzie if an investor redeems securities of the Fund during specific periods. Not all purchase options are available under each series of the Fund, and the charges for each purchase option may vary among the different series. For further details on these purchase options, please refer to the Fund's Simplified Prospectus.
